In the interest of public service, the Governor of Mizoram is pleased to upgrade the existing Cyber Crime Cell in the office of S.P. CID(Crime) to the Status of Cyber Crime Police Station with immediate effect.

The Cyber Crime Police Station will continue to be assigned the following roles and functions :-

- 1. Transfer of cases: For any cases purportedly involving cyber crime after being reported and registered at the concerned Police Station, approval of Director General of Police, Mizoram should be invariably obtained through concerned DIG Range for transfer to Cyber Crime Police Station for investigation, depending on the merit of the case.
- 2. Services: For retrieval of digital evidence, any concerned Sub Divisional Police Officer can project requisition to scan and access the flash memory of any electronic device suspected of being used and seized in the case for Call Detail Records (CDR), stored digital data, etc.
- 3. Consultancy: For efficient and successful handling of cyber crime cases, the Police Station will perform and exercise all the powers and duties of a Police Station pertaining to Cyber Crimes and render technical expertise and provide assistance to Investigating Officers of normal Police Station whenever necessary.
