2. Application

These rules shall apply to the post(s) specified in column (1) of the Las mollerroessi • Annexure-I annexed, to these rules.

Method of recruitment, The method of recruitment, age limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (14) of the aforesaid Annexure-1.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.

5. Disqualification

No person.

- (a) Who has entered into or contracted a marriage with a person having a spouse living, or
- (b) Who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post(s);

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of this rule.

6. Training and Departmental Examination

Every Government servant recruited under these rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

7. Powers to transfer

Notwithstanding anything contained in these rules, the Governor of Mizoram, in public interest, shall have the right and power to transfer any officer so recruited under these rules to any other post or position which is equivalent in rank or grade.

8. Power to relax

Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing and in consultation with the Mizoram Public Service Commission through the Department of Personnel & Administrative Reforms, relax any of the provisions of these rules with respect to any class or category of persons.

9. Reservation and other concessions

Nothing in these rules shall affect reservation relaxation of age limit and other concessions required to be provided for the Scheduled Caste /the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Government or the Government of Mizoram from time to time in this regard.
