No.A.12018/48/2016-P&AR(GSW) the 16th January, 2018. In exercise of the powers conferred by the proviso to Article 309 of the Constitution the Governor of Mizoram is pleased to make the following Rules regulating the method of recruitment to the post(s) of Informatics Officer under Information & Communication Technology Department, Government of Mizoram namely :-

- Short title and commencement
- (1) These rules may be called the Mizoram Information & Communication Technology Department (Group 'A' posts) Recruitment Rules, 2017
- They shall come into force on the date of their publication in the Official Gazette.
 - These Rules shall apply to the posts specified in Column I of Annexure-I hereto annexed.
 - The number of the said post(s), classification and the scale of pay/Pay Band & Grade Pay attached thereto shall be as specified in Column 2 to 4 of the aforesaid Annexure-I Pay

The method of recruitment, age.limit, qualifications and other matters relating to the said post shall be as specified in Column 5 to 14 of Annexure-I.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time. Disqualification

(b) Who, having a spouse living, has entered into or contracted a marriage with any other person shall be eligible for appointment to the said post(s);

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other valid grounds for doing so, exempt any such person from the operation of these Rules.

Every Government servant recruited under these Rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

Notwithstanding anything contained in these Rules, the Governor of Mizoram, in public interest, shall have the right and power to transfer any officers, so recruited under these Rules to any other post or position which is equivalent in rank or grade.

Where the Governor is of the opinion that it is necessary or expedient to do so, he may, by order and for reasons to be recorded in writing, in consultation with the Mizoram Pubic Service Commission through the Department of Personnel & Administrative Reforms, relax any of the provisions of these Rules with respect to any class or category of persons.

Nothing in these rules shall affect any reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes/the Scheduled Tribes and other categories of persons in accordance with the order issued by Central Government or Government of Mizoram from time to time in this regard.

All Rules pertaining to these posts framed by the Government of Mizoram issued under Memo No.A.12018/63/2008-P&AR(GSW) dated 08.12.2011 and published in the Mizoram Gazette Extraordinary Issue No.558, 559, 562, 563 & 564 dated 14.12.2011 and the subsequent amendment issued vide No.A.12018/63/2008-P&AR(GSW) dated 06.06.2013 and published in the Mizoram Gazette Extraordinary Issue No. 283, 284, 285,286, & 287 dated 14.06.2013 respectively shall stand repealed from the commencement of these rules.

Provided that any order made or anything done or any action taken under the Rules so repealed or under any general order ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these Rules.
